Restless Pines Farm, its management, competitions organizing committee, officials or competition staff and volunteers are in no way responsible for accident, injury or damage to any rider, exhibitor, spectator, groom, attendant, trainer or other employee; or animals, nor theft, loss or damage to animals, vehicles or equipment.

As required by Article A801, every entry at an EC-sanctioned competition shall constitute an agreement by the person responsible that the owner, lessee, trainer, manager, agent, coach, driver or rider and horse shall be subject to the EC constitution and all rules of EC and any additional rules set by the competition.

It is the responsibility of all individuals participating in any capacity in the EC-sanctioned competitions to be knowledgeable regarding the EC constitution and the applicable rules, if any, imposed by the competition. Do not participate in this EC-sanctioned competition in any capacity if you do not consent to be bound by the constitution and rules of EC and any additional rules imposed by the competition.

This series will be an amazing opportunity to bring all levels of our sport together from Grassroots athletes to our top athletes in the Maritimes. The opportunity for young athletes to have top quality facilities to learn and grow will only enhance their development and progression in the sport. Our two show series will be all about the competitor with an affordable entry, great prizes and safety measures in place. Rules & Regulations

The Restless Pines Tournament and the Restless Pines Fall Finale competitions are sanctioned as a Bronze and Gold competition member of EQUESTRIAN CANADA c/o House of Sport 2451 Riverside Drive, Ottawa, Ontario, K1H 7X7 and is governed by the rules of EC." (A602.1)

Every class offered herein is covered by the rules and specifications of the current rules of EC and will be held and judged in accordance with the EC Rule Book." (A602.2)

When registering for EC sanctioned competitions, athletes must indicate the name of their coach on the entry form or specify that they are selfcoached. Coaches from other countries, must be in good-standing with their home federation and must declare/have proof of insurance. See Rules of Equestrian Canada, Section A, General Regulations, Article 102, Safe Sport Environments.

The standard by which conduct or treatment will be measured is that which a person, informed and experienced in generally accepted equine training and exhibition procedures, would determine to be neither cruel, abusive, nor inhumane (A517.2). Any horse entered in any class at a competition may be selected for equine medication control testing while at the event location." (A602.5)

Per Article A801, every entry at an EC-sanctioned competition shall constitute an agreement by the person responsible that the owner, lessee, trainer, manager, agent, coach, driver or rider and horse shall be subject to the EC constitution and all rules of EC and any additional rules set by the competition. It is the responsibility of all individuals participating in any capacity in EC-sanctioned competitions to be knowledgeable regarding the EC constitution and the applicable rules of EC and the additional rules, if any, imposed by the competition. Do not participate in this EC- sanctioned competition in any capacity if you do not consent to be bound by the constitution and rules of EC and any additional rules imposed by the competition." (A602.7)

PLEASE NOTE: All horses attending Equestrian Canada sanctioned competitions must have met the requirements of Article A519, Vaccinations. See Rules of Equestrian Canada, Section A, General Regulations, Article A519, Vaccinations.

ARTICLE A519 VACCINATIONS

All horses attending EC sanctioned competitions must have been administered Equine Influenza and Equine Herpes Virus (1 and 4) vaccinations within six (6) months (+21 days grace period) before arrival at the competition. No horse shall have received vaccination within seven (7) days prior to arrival at the event. Horses not in compliance with this rule may be asked to leave the event site at the discretion of competition management.

The frequency of vaccine administration should be as recommended by the vaccine manufacturer or veterinarian. It is recommended that vaccines be administered by or under the direction of a veterinarian. Competition management may request supporting documentation confirming a horse's compliance with mandatory vaccination requirements.

In the case of a horse that is unable to receive either of the vaccines, a letter must be provided with the entry form from a veterinarian, on official letterhead, stating the equine cannot be vaccinated due to medical concerns. At the discretion of competition management, a log of the horse's temperature prior to arrival at the event site or during the event can be requested.

Rules & Regulations

EQUESTRIAN CANADA STATEMENT OF PRINCIPLES – HORSE WELFARE

1. EC requires adherence to humane treatment of horses in all activities under its jurisdiction.
2. All participants shall be bound by the Horse Welfare Code of Conduct.
3. EC is committed to:
 - a. upholding the welfare of the horse, regardless of monetary value, as a primary consideration in all activities;
 - b. requiring that horses be treated with kindness, respect, and the compassion that they deserve, and that they never be subjected to maltreatment;
 - c. ensuring that owners, trainers, and exhibitors and their agents exercise appropriate care and responsibility in the handling, treatment, and transportation of their horses, as well as horses placed in their care for any purpose;
 - d. providing for the continuous well being of the horse by encouraging routine inspection and consultation with health care professionals and competition officials to achieve the highest possible standards of nutrition, health, comfort, and safety;
 - e. continuing to support scientific studies on equine health and welfare;
 - f. requiring owners, trainers, and exhibitors to know and follow their sanctioning organization's rules, and to work within industry regulations in all equestrian competitions; and,
 - g. reviewing, revising, and developing competition rules and regulations that protect the welfare of the horse.

Protect Your Head! Helmets are Mandatory

- a. See A905 and G102. At all times, persons mounted at an EC-sanctioned event location must wear approved protective headgear.
- b. Protective headgear must be certified under one of the following standards: ASTM (American Society for Testing Materials), or SEI (Safety Equipment Institute, Inc.); BSI/BS EN (British Standards Institution); EN (European Union Standards); or AS/NZS (Australian/New Zealand Standards).
- c. Protective headgear must be properly fitted and securely fastened by a safety harness permanently affixed to the helmet.

The Restless Pines Tournament is conducted under the current EC Rule Book.

Applicable EC Rule Book references are sometimes noted but are not a substitute for knowledge of the actual Rule Books. Competitors are expected to know their sport rules.

Closing date for Entries:

Restless Pines Tournament – June 29, 2026

Enter online ONLY at www.horseshowsonline.com

Entries not received by closing dates will be subject to a late fee of \$30 (no exceptions).

Entries may not be accepted if the show has reached capacity.

1. Memberships:

- a. All Canadian owners and riders must have a valid EC Gold (or higher) or, for Bronze classes, a Bronze Sport License (A205)- (A207) OR purchase a Single Event Upgrade (A211) or License Transfer (A212) for a Silver or Bronze Sport License to Gold License; or be a member in good standing of their own National Equestrian Federation.
- b. Competitors also require provincial territorial sport organization (PTSO) membership.
- c. All athletes and owners must be holders of a current membership in their home country's national federation, and foreign entries must sign an affidavit.
- d. All athletes competing in Amateur classes must possess a valid EC Amateur Card and must present it to the Competition Secretary upon request (A902).
- e. Exception: Lead line riders who require only an NSEF or other PTSO membership.
- f. Please be aware that NSHJA membership is required to participate and/or benefit in the NSHJA Programs.
- g. Please be aware, some classes require only Bronze EC memberships, and some require Gold. If you choose to compete with a Bronze membership in Gold classes, you must upgrade your membership or purchase a single event upgrade.

EC SPORT LICENSING 2026

SAFETY, INCLUSIVITY, & EXCELLENCE

Your guide to the latest updates for the competition season in Canada

IMPORTANT CHANGES have been implemented to enhance the safety and inclusivity of equestrian sport. Whether you're an athlete, parent, coach, official, or competition staff, your role is crucial in upholding these standards. Here's what you need to know:

SAFE SPORT TRAINING PREREQUISITE:

- The two free EC Safe Sport training modules must be completed before purchasing a Sport Licence. Check your training status on MyEC by clicking on the ECampus button.

DISCONTINUED TEMPORARY LICENCES AND TEMPORARY HORSE REGISTRATIONS:

- Temporary EC Sport Licences are now discontinued at competitions. All riders, owners, and coaches must possess an EC Sport Licence to participate in events. All horses must have a Horse Recording where level and division require.

AVAILABLE SHOW LEVEL UPGRADES:

- Explore higher-level competitions with temporary upgrades via your MyEC Portal. Note: National Rankings Points are not tabulated for upgraded results.

COACH STATUS REMINDER—2026 SEASON

- Coaches attending EC-Sanctioned competition must hold a valid Licensed Coach Status. Any Coach with Registered Coach Status must purchase a Single Event Upgrade for \$55.00. This purchase can be made through the My EC account.
- Coaches without a valid Licensed Coach Status or Registered Coach Status with Single Event Upgrade Status are not eligible to be represented as a coach at EC-Sanctioned events and may be subject to fines. Please complete your requirements in advance to avoid any fines and delays.

DECLARE YOURSELF A SELF-COACHED ATHLETE

- Athletes without a coach on-site can declare themselves as self-coached by entering their own **EC SPORT LICENSE NUMBER** or enter "self-coached" in the **COACH FIELD** on their registration/entry form.
- Please note: Coaches that **DO NOT ATTEND** the events **SHOULD NOT BE LISTED** on the entry form.

2. EC Horse Recordings (A602.8)/FEI Passports

a. Horse Recordings are mandatory for all horses and ponies entering EC Gold sanctioned competitions. Horses must be entered under the name and with the same owner as appearing on the Horse Recording. (A402) EC sanctioned competitions require the following (where applicable): An active Horse Recording, EC National Passport (with active Horse Recording component) or FEI Passport (with active Horse Recording component). Foreign owned horses may compete with national passports recognized by the FEI. USEF horses may compete with a valid USEF Horse Recording Number. Persons responsible for US or other foreign- owned/leased horses competing in EC-Sanctioned Competitions must complete an affidavit stating that their horse(s) are eligible to compete as entered and must declare the jumper registration number(s) that have been assigned by their respective national federation. If a Horse Recording, an EC National Passport or FEI Passport cannot be produced, the person responsible must complete a Temporary Horse Registration form and pay the temporary registration fee. Results achieved while competing with a Temporary Horse Registration may not be used to qualify for year-end awards, championship competitions, finals or subsequent competitions requiring qualification. Bronze competitors do not need an active horse recording number.

3. Equine Medication Control and Fees

- a. Any horse entered in any class at a competition may be selected for equine medication control testing while at the event location (A602.5)
- b. All EC-sanctioned competitions are required to collect a prescribed medication control fee for each horse entered. All fees collected are to be remitted using the Equestrian Canada Form to the Equestrian Canada Equine Medications Control Committee or its designate as per the Competition Administration Policy. This fee is to be identified on the entry form as a stand-alone item and not bundled or combined with other fees. (A1008).
- c. Bronze competitors pay \$4.00 and Gold competitors pay \$8.00.
- d. The person responsible is the individual responsible and accountable for the care, training, custody and performance of the horse. The person responsible may be the trainer or may be an owner, rider, driver, agent or coach. The person responsible must be an adult and must have an EC individual or group license, with the exception of a Junior Exhibitor parent or guardian. (A213) (A1011).

4. Eliminations

The EC "2 Refusal Elimination Rule" in all jumper, hunter and equitation classes is followed at restless Pines. The competitor has the right to jump a single obstacle after retiring or after being eliminated provided that the obstacle is part of the course of the current competition (this does not apply to elimination resulting from a fall). Falls will result in elimination, rider will not be permitted to remount.

5. Entries

- a. Entries must be received online by the Closing Date.
- b. One horse per entry form.
- c. All entries must be completed on an entry form, on line (i.e., no phone, email or Facebook entries). All entries must be complete with proper signatures, complete address, membership and passport numbers.
- d. The Show Committee has the right to refuse or limit entries as circumstances warrant.
ENTRIES ARE PROCESSED IN ORDER OF DATE/TIME RECEIVED.
- e. Substitution of entries: Will be at the discretion of the Organizing Committee.
- f. Payments: Stabling and administration fees must be paid up front with entry. Entries without payment will not be accepted.

6. Cancellations

- a. If cancellations are received in writing prior to noon 7 days before the show, all entry fees will be refunded less the admin fee and a \$50 scratch fee. After this date, there will be no refunds unless the owner or rider presents an original veterinarian certificate or medical doctor's certificate (in the case of the rider) dated within 48 hours of the commencement of the competition, the scratch fee will be waived in this circumstance.
- b. There will be no refunds except in accordance with this rule.
- c. The person responsible for any horse that does not compete in a class in which it was entered and is not scratched according to these procedures is fully liable for all fees. A816.
- d. After commencement of the competition, class scratches will have no fee if scratched before the first horse competes in the class. After the first horse has competed, there are no refunds.

7. Adds/Scratches/Changes

- a. Class adds, drops (scratches) and class changes are required in writing on an official form, or on-line. In order to be refunded the class fee, scratches are due in the competition office prior to the start of the applicable class. Please note, a \$20 charge per class will be added for day of adds. We encourage riders/trainers to add the day prior at no charge to allow for more accurate scheduling. Classes ridden with no written add prior to the start of the class will be charged an additional \$20 Rode Not Entered Fee. Day of adds will be based on schedule availability and management approval. There is no guarantee that day of adds will be accepted. As per GR A801.9 Competitors are responsible for their own errors and those of their agents in the completion of their entry forms. c. Post entries will go first in all classes of that day.
- d. All scratches must be recorded in the show office. See Rule 5 above.

7. Age - Junior Riders

Individuals are juniors until the end of the calendar year in which they reach the age of 18. Juniors' ages are required to be stated on the entry form, and birth certificates are to be available on request. Riders from the United States qualify as juniors with the United States Equestrian Federation through December 1st of the year they turn 18 years of age.

Equestrian Canada Rules state:

Junior A - from the beginning of the calendar year in which they turn 16 until the end of the calendar year in which they turn 18

Junior B - from the beginning of the calendar year in which they turn 13 until the end of the calendar year in which they turn 15

Junior C - until the end of the calendar year in which they turn 12.

8. Amateur Eligibility

(Article G108.11) Any person who has ridden on a Senior National Eventing or Jumping Team is not eligible to compete in the amateur division for a period of two years from the date of the last competition at which the athlete rode for the team. Athletes who are on the Jumping Short List for the Canadian Team for the current year are excluded from amateur classes for that year.

9. Payment

- a. All stabling fees, medication fees, Jump Canada Levy, NSHJA and administration fees must be paid in full prior to the competition. Entry fees may be secured with an open cheque.
- b. Payment can be made by cash, cheque, email money transfer.
- c. Cheques are to be made payable to Restless Pines Farm. No post-dated cheques.
- d. A signed, blank cheque is required for open accounts. Open accounts must be approved by Competition Secretary.
- e. If payment is not made in full by 11:59pm AST on the last day of competition, a \$50 late payment fee will apply.
- f. If an entry remains unpaid, the owner and rider associated with that entry will not be accepted to attend any subsequent Restless Pines events/competitions.

Rules & Regulations

10. Returned Cheques

- a. A \$50 charge will be assessed on all returned cheques.
- b. Unsettled accounts will be referred to EC, which will result in suspension from all EC competitions.

11. Schedule

- a. The Organizing Committee reserves the right to combine or cancel any class or division with insufficient entries.
- b. Any class/division with fewer than 4 entries may be combined, cancelled or run with no prize money offered.
- c. Sign up orders of go will be offered. Management requests your cooperation by being respectful of the time. The Judge has the authority to eliminate an entry for delay deemed to be unreasonable.
- e. Management reserves the right to make class and schedule changes at any time, subject to Article A505.

12. Concussion

Accidents & Return to Play rule: In the event of a fall/accident where a concussion can be reasonably suspected, the competitor must receive medical clearance by qualified medical personnel onsite through the EC Accident Injury Report Form before continuing to compete. The competitor is solely responsible for ensuring the onsite medical assessment takes place. Should a competitor refuse to be evaluated, they will be disqualified from the competition. If onsite qualified medical personnel suspect a concussion or believe the competitor may be at risk of concussion due to the nature of the fall or impact, the competitor will be suspended from competition and placed on a Medical Suspension List until medically released. Competitors will remain on the EC Medical Suspension List until they submit an EC Return to Play Form, signed by a licensed physician, to EC. No competitor shall compete at EC sanctioned competitions while on the EC Medical Suspension List and competition organizers may refuse entry to anyone currently on the list. A101 2.

13. Competition Numbers - Schooling Rules

- a. Numbers must be worn and visible at all times in the schooling and warm-up areas and in the competition ring (A814). Any horse wearing the incorrect number may be eliminated.
- b. FEI Schooling rules will apply.
- c. Numbers will be released ONLY when Entry Form is fully complete and payment is secured with the Show Office.

14. Attire | Formal

a. Dark, muted or similar colored, or red (scarlet) coats; white or fawn breeches, a white tie, choker (unless the shirt, by design, has the choker built in for its intended use) or hunting stock, and a white or lightly colored shirt. Traditional black or brown boots are required. Half chaps are permitted as long as the color matches the paddock boots being worn. Members of the Armed Services or the police may wear the service dress uniform with protective headgear. Classes requiring formal attire are the Grand Prix or the Hunter Classic. Riders will be notified by management where exceptions to formal attire are permitted. We ask that you please be sure you are dressed according to the protocol for the class you are entering in. See also G109.

15. Attire | Standard Jumper

Coats are not required. Breeches of any color are permitted. Shirts (polo shirts are permitted) with collars and sleeves (sleeves may be either long or short), tucked into the breeches. Sleeveless shirts and shirts with exposed hoods are not permitted. Traditional black or brown boots are required. Half chaps are permitted if the color matches the paddock boots being worn. All other classes will require standard attire. In extreme weather conditions, the use of jackets, sweaters or raincoats may be approved at management's discretion.

Rules & Regulations

16. Levies

- a. NSHJA: A fee of \$10.00 per horse for the NSHJA is applicable.
- b. Jump Canada: A fee of \$25 per horse entered in the Gold competition is applicable and remitted to Equestrian Canada. This is used to support regional and national programs designed to foster the activities of hunter/jumper riders, owners and the industry at large.

17. Combined Hunter Division

Divisions will be combined based on Federation Rules if not filled. One championship will be awarded per combined division.

18. Prizes: Hunter Divisions

- a. Placings to 8th place. Ribbons to 8th place.
- b. Other prizes to be awarded at the discretion of the Organizing Committee
- c. See class lists for prize money by class. Prize money will be credited to accounts or paid in cash.

19. Presentations

- a. Hunter competitors, if to return to the ring for jog (unless otherwise noted) and presentation dressed appropriately and with horses in a bridle when required. G401.5 Option A or B will be used for jogging for soundness.
- b. Jumper competitors must be neat and tidy. Riders should be mounted for presentations.
- c. A Victory Gallop may take place for the Mini-Prix and Grand Prix classes. Salute and respect paid to sponsors in attendance is required. Failure to cooperate may result in forfeiture of prize money.

20. Division Championships

Champion and Reserve Champion will be awarded in Hunter and Jumper divisions, with a prize to the Champion. Ties for champion or reserve champion will be decided by the horse that places higher in the over fences portion of the division, (G205) or in the case of jumpers by the horse that places higher in the class with the largest prize money. If there is still a tie, champion will be determined by a coin toss. For competition awards, EC points rules apply.

21. Stabling

Very limited stabling is available. We will be holding a schedule that allows for daily ship in and ship out. Stabling will be reserved for competitors travelling from farthest away.

22. Pony Measurement

- a. Measurement of ponies will be in the barn Friday at 7:30 a.m.
- b. Horses may be measured randomly.
- c. ARTICLE A1104 TEMPORARY MEASUREMENT FORMS: Until a horse or pony is eight years of age, a temporary measurement form must be obtained annually. Such forms remain valid for the calendar year.

23. Schooling

- a. In the Hunter Divisions, only pony hunters will be offered an Open Schooling Card, one per pony. Please indicate on the entry form. No placings or ribbons.

Rules & Regulations

24. General Information and Grounds Rules

- a. we have added a 2 acre parking area please use this space along with members from your stable travelling with you to park together.
- d. Damage: all owners and participants are responsible for any damage incurred by them, their agents or employees, to stalls, buildings, and other property on the competition grounds, and shall be billed accordingly.
- e. A disaster plan is in place, as per EC requirements, and available for inspection in the Competition Office.

25. Dogs

All dogs MUST be kept on a leash at all times while on the property. Unruly or noisy dogs may be asked to leave.

26. Hunter Stake and Pony Stake

Pony Hunters and Hunters must have entered and competed in a division in order to be eligible to enter the Pony Stake or Hunter Stake and must be entered in the respective Stake prior to the first class in which the pony or horse competes.

27. Jumper Nomination Fee

Jumpers must pay the applicable nomination fee unless competing in a division or class that does not require nomination. Nomination fee is non-refundable. Jumpers must enter and compete in at least one other class in a division in order to enter a Mini Prix or Grand Prix.

28. Handsfree Devices

Earphones and/or other electronic communication devices are strictly prohibited in all EC/FEI Competitions, and such usage is penalized by elimination. The use of one earbud/earphone is allowed while mounted except in the competition rings.

29. Insurance

All owners and competitors are personally responsible for damages to a third party caused by themselves, their employees, agents or their horses. They are strongly advised to hold third party insurance to cover activities at equestrian events.

30. Vet and Farrier

The official competition vet and farrier phone numbers are posted in the Competition Office and in Stabling Areas. All owners and participants are responsible for any bills for requested vet and farrier services. Any person not meeting this obligation may be deemed to be not in good standing and may be denied entry at future competitions.

31. Hospitality

32. Photography

The Organizing committee and sponsors reserves the right to use competitor photographs in promotional material and on social media unless another arrangement is made in writing with the Organizing Committee.

33. Hors Concours

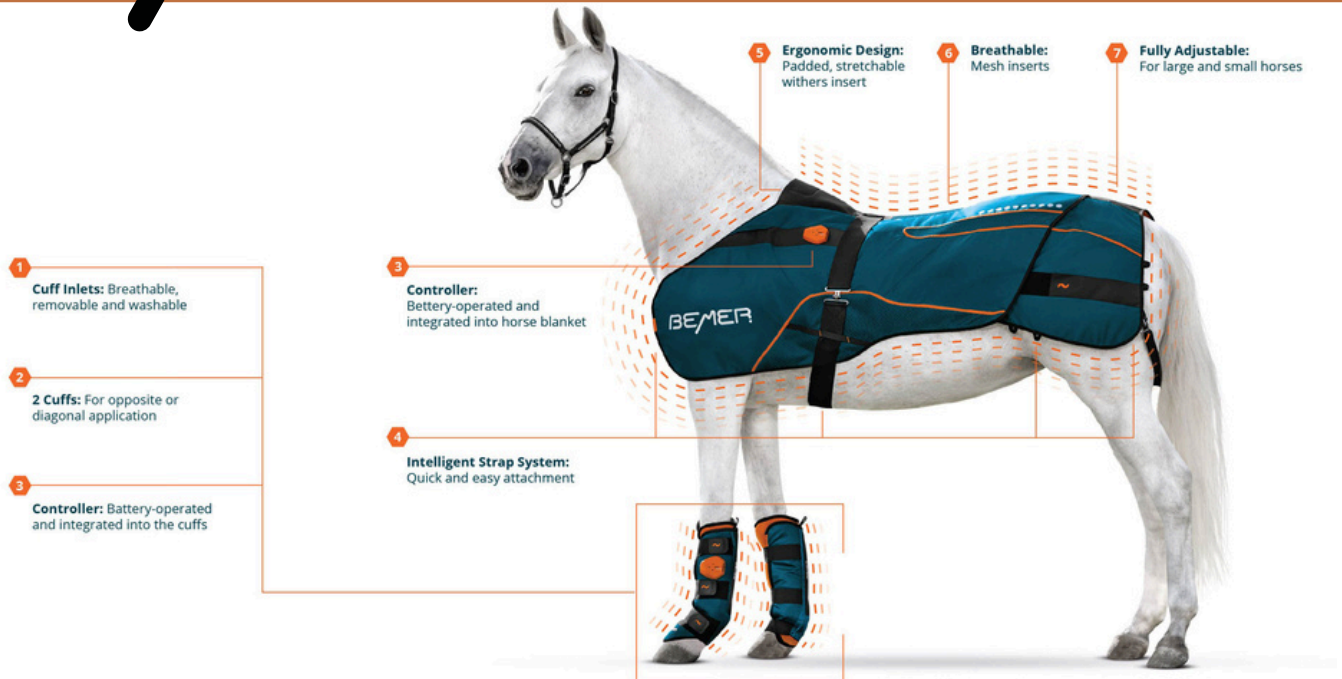

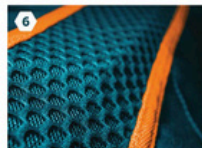

Rules & Regulations

34. Management

Subject to EC Rules, management reserves the right to interpret all questions and conditions regarding or arising out of the competition without claims, damages or recourse of any kind. For all questions not covered in these rules, horse show management shall decide regulations, and management's decision is final. Management reserves the right to refuse, accept conditionally or to cancel any entries, disqualify riders or exhibitors, prohibit claim damages, change any course, cancel or combine any unfilled classes, reschedule classes, change rings or rotate judges, and to change specifications in jumper classes at any time.

35. Smoking

Smoking or vaping is not allowed within 6 meters of any barn or building.

36. Biosecurity

BioSecurity is everyone's responsibility! Restless Pines is committed to providing a safe and healthy environment for all participants and their horses. All participants are requested to practice good disease prevention practices. Travelling and competing horses are at an increased risk for contracting and spreading contagious diseases. Avon Animal Hospital is the official Restless Pines Farm veterinarian. All horses entering the grounds must not have been in contact with any sick horses within the last 15 days. They must not exhibit any sign of illness. Any horse that has been sick or exposed to an infectious disease within the last 15 days must have their attending veterinarian contact the competition veterinarian prior to entry to the show grounds. All horses are required to be verifiably current on Influenza and EHV 1-4 vaccines (within 6 months). All horses while on the competition grounds are expected to have their temperatures taken and recorded on a daily basis during the show. Please have temperature records available upon request. We require that any horse with a rectal temperature above 38.5 C (101.8 F) report to show management and/or the show veterinarian immediately. The show veterinarian will examine any horses with an elevated temperature or other signs of illness prior to being allowed to show.

- Failure to comply may result in your horses being required to enter our quarantine isolation barn or leave the show grounds. Any horse identified to have or is suspected of having a contagious disease will be removed to the isolation area. It is advised that all competitors have a contingency plan in the event that a sick horse in their care needs to be removed from the show grounds. We require that braiders/grooms/riders use the hand sanitizers, provided in the stall areas after handling any horse. Please avoid any direct or indirect contact between horses, in particular nose to nose contact and use of any common feed/ drinking buckets. The early detection of any contagious disease is the key to prevention of a disease outbreak. Following these simple requirements will be a major step in the prevention of the spread of disease. We appreciate your cooperation and look forward to everyone having a successful horse show experience.

37. Equine Vaccinations

All horses attending EC sanctioned competitions must have been administered Equine Influenza and Equine Herpes Virus (1 and 4) vaccinations within six (6) months (+21 days grace period) before arrival at the competition. No horse shall have received vaccination within seven (7) days prior to arrival at the event. Horses not in compliance with this rule may be asked to leave the event site at the discretion of competition management.

The frequency of vaccine administration should be as recommended by the vaccine manufacturer or veterinarian. It is recommended that vaccines be administered by or under the direction of a veterinarian. Competition management may request supporting documentation confirming a horse's compliance with mandatory vaccination requirements.

In the case of a horse that is unable to receive either of the vaccines, a letter must be provided with the entry form from a veterinarian, on official letterhead, stating the equine cannot be vaccinated due to medical concerns. At the discretion of competition management, a log of the horse's temperature prior to arrival at the event site or during the event can be requested.

Rules & Regulations

Documentation should consist of one of the following:

- a. In the case of vaccines given by a veterinarian, the Person Responsible, upon request by Competition Management, should provide documentation from the Veterinarian, documenting that the equine in question received the vaccinations on the date administered and the name of the vaccine.
- b. In the case of vaccines administered by a person other than a veterinarian, the Person Responsible, upon request by Competition Management, should provide a receipt of the vaccine purchase which is signed by the Person Responsible, the equine's name, the serial number and expiration date of the vaccine and the date of administration.
- c. In the case of an equine that is unable to receive either of the vaccines due to a history of adverse reactions, the Person Responsible, upon request by Competition Management, should provide a letter from a veterinarian on official letterhead stating the equine cannot be vaccinated due to medical concerns and a log of the equine's temperature taken at least twice daily for the seven days prior to arrival at the competition grounds. These equines should also have their temperatures taken and recorded twice daily while on the competition grounds. The log of temperatures taken should be provided to the Competition Management, Steward, Official Veterinarian or Technical Delegate when requested. It is intended that vaccination requirement compliance will be universally enforced for all equines entering Equestrian Canada sanctioned competitions beginning in 2020.

It is the intent of Restless Pines Farm to offer a safe and healthy competition environment for all exhibitors and their horses.

DISCLAIMER: the Organizing Committee of the Restless Pines Farm competitions their officers, directors, employees, and representatives, the officials, volunteers and employees of those responsible for this competition shall not be held responsible for any accident, illness or other damages, that may occur to a competitor, horse, spectator, rider, groom, handler, or any other person present at the competition. All owners and competitors are personally responsible for damages to third parties or property caused by themselves, their agents, or their horses.

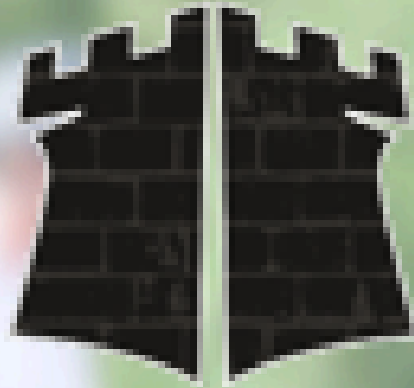
38. Coaching

When registering for EC sanctioned competitions, athletes must indicate the name of their coach on the entry form or specify that they are selfcoached. Coaches from other countries, must be in good-standing with their home federation and must declare/have proof of insurance . See Rules of Equestrian Canada, Section A, General Regulations, Article 102.2, Safe Sport Environments."

39. Number of Classes

Show results from the model and flat classes could be used to support a 3 years old horse's candidature application to the Lieutenant Governor and Governor General Cups at the Royal Agricultural Winter Fair, in Toronto in November.

Model: In hand presentation judged on conformation, temperament, movement and physical health. 50% conformation, 50% movement and health.

Flat: under saddle presentation at the walk, trot and canter in both directions judged on conformation, temperament, movement and health. 60% movement and health. 40% conformation.

Over Fences: Over a 2'3" courses of maximum 8 jumps judged on style, temperament, movements and presentation.

Proof of age is mandatory before entering any young hunter classes. A horses baby green status will not be affected by participation in the series. All riders and handlers must have current EC bronze memberships. Ponies can enter the model and flat classes only. Adults can ride ponies in the flat phase.

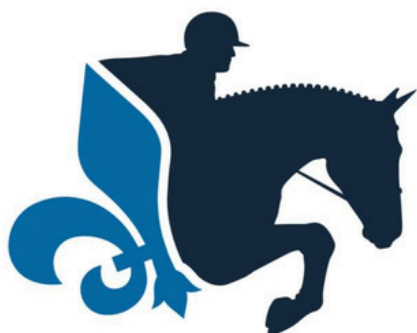

JC Medal Class (G1106)

Prize Money: Medals/Ribbons

1. PHASE 1: OVER FENCES

a) Course: course of not less than ten jumps 3'6" (.1.10 m) high. Course specifications. The course must include at least one combination which includes an oxer, at least two changes of direction, 1/3 of the fences must be oxers. Further to the above specifications, additional tests are to be included in the course. Three of the following: bending line, narrow jump, roll back turn, fence at the end of the ring, long approach to a single fence.

b) The course may not be changed or altered for ponies.

c) The class is judged according to Article G1008, Class Routine Over Fences.

2. PHASE 2: ON THE FLAT All contestants or a minimum of eight shall be called back to perform at a walk, trot and canter. The judge will call for additional requirements from Article G1009, Tests.

3. SCORING: Medal classes will be judged 60% over fences and 40% on the flat.

4. Riders in a JC Medal Class may not cross enter into a 3' (0.90m) medal class at the same competition.

Class 500G

CET Medal Class (G1111)

The class shall have a minimum of two phases; a flat phase and either a gymnastic or jumping phase. The flat phase must immediately follow the gymnastic or jumping phase. All riders, or a minimum of 12, who completed the course are eligible for the flat phase. See article G1111 for further details.

d) The CET Medal Classes will be judged 60% over fences and 40% on the flat.

Class 501G

NSHJA Pony Development Medal

Class 502B

Medals/ Ribbons only.

Open to Junior riders on ponies in the pony development division. Fence heights and distances to be adjusted for respective pony sizes. Riders will have the opportunity to walk the course.

To be shown over a course of eight or more hunter type fences with at least two changes of directions and including at least two tests (see EC rules Article G1009, Tests). Minimum of the top 4 to ride-off at the judge's discretion.

Equitation Medal Classes

0.90m NSHJA Jumper Mini Medal

The NSHJA Mini Medal Class to be held under the same rules and regulations as the CET Medal (see Article G1110) with the exception of the following:

Phase Requirements

- Jumping Phase – maximum 0.90m
- Flat Phase – the counter canter is strongly recommended.
- Gymnastic Jumping Phase – (NSHJA Mini Medal Finale held during the Coveside Classic) maximum 0.80m

The class will run with a minimum of two phases: a Flat Phase and a Jumping Phase. The flat phase must immediately follow the jumping phase. All riders who completed the course are eligible for the flat phase. All horse/rider combinations must stay the same for both phases.

Eligibility Requirements

- Open to riders of all ages who are current EC Sport License holders for the level in which they are competing.
- Senior riders must be amateurs as per Article G108 and possess a current EC amateur card.
- Open to juniors or amateurs that hold a current NSHJA membership.
- Riders competing in 1.20m or higher jumper divisions are not eligible.
- Riders may not cross enter between the NSHJA Mini Medal and the CET Medal class at the same competition.

Tack and Equipment

- There are no restrictions on saddles.
- Change of tack and equipment is permissible between phases.
- Blinkers are forbidden.
- No martingales of any kind are permitted in the Flat Phase.
- Only running martingales used in the conventional manner are permitted in the Jumping Phase. Standing martingales, draw reins, or restricted running martingales are prohibited.
- Reins must be attached to the bit(s) or directly to the bridle. Gags and Hackamores are not allowed for the Flat Phase. Bit Convertors are allowed.

Jumping Phase

- The course will be a minimum of ten jumps with a height of 0.9m with spreads to 1.0m. Distances will not be changed for ponies.
- The course must include a double and triple combination with at least one spread fence in each. Two other spread fences are required elsewhere on the course.
- A liverpool is mandatory.
- The course should be more technical than the type used in the regular junior/amateur jumper classes.
- A time allowed must be established based on 350 metres per minute.
- Trainers may walk the course with rider.

Flat Phase

·Not more than 20 riders at a time will show at the working walk, the working trot sitting, the working trot rising, the working trot showing a lengthening of stride, the working canter, the working canter showing a lengthening of stride, counter canter is strongly recommended. Not more than 12 shall counter canter at one time.

Judging

- The over fences phase to be conducted under current EC jumper rules. Note: Elimination after the second refusal.
- Time faults penalized one (1) penalty point for every four (4) commenced seconds over the time allowed.
- In addition, the class will be judged on seat, hand, guidance, and control.
- The NSHJA Mini Medal Classes will be judged 60% over fences and 40% on the flat. Exception: At the NSHJA Mini Medal Finale, the competition will be judged 50% Flat/Gymnastics phase and 50% Jumping phase.

Heights:

Equitation over Fences – Junior B & C Riders:

Small ponies: 2'3 (0.7 m)

Large ponies: 2'9 (0.85m)

Horses: 3' (0.9m)

Fence heights and distances must be adjusted for the respective hunter heights

Modified Equitation A Over Fences:

3' (0.9m)– only riders showing in the Children's Hunter Division may enter

3'3 (1.0m)– open to A riders competing at 3'3 height

3'6 (1.10m)– open to A riders competing at 3'6 (or above) height

Any competitors on large ponies will compete at 2'9 height and respective distance.

Tests:

Equitation Flat Classes:

Riders to demonstrate Walk, Trot, Sitting Trot and Canter on command, both directions. They shall then line up and the top 4 will be asked to execute individual tests at the judge's discretion.

No individual test may be requested that is not included in the individual tests in Article G1009, Tests.

The judge may ask questions concerning horsemanship, anatomy of the horse, tack, stable management and others.

For change of direction at the canter (where allowed), the Judge must specify if a change of lead is required.

Flat phase test for each division will be communicated by NSHJA.

Equitation Over Fences Classes:

Riders to compete over a course of not less than 8 jumps. The fall of horse or rider, or two disobediences on course shall cause the entry to be eliminated from the class.

Individual tests may be selected at the Judge's discretion, from those listed in Article G1009, Tests.

Turn Out:

A turn out score, on a scale of 1 – 10, will be added to each competitor's score during the first over fences class.

(Article G1003) While competitors and judges should bear in mind that entries are being judged at all times on ability, it should be noted that neatness is a first requisite regarding rider's dress.

Jacket – conservative color; jodphurs or breeches; shirt and tie, stocks or chokers must be worn; boots; black or brown smooth leather half-chaps are permissible providing they match the boot color.

Conservative -coloured protective headgear (per Article G1004) with no additional adornments.

Ribbons:

All classes will be pinned to 8th place, with ribbons to 6th place. A division champion and reserve champion will be presented for Equitation A/B/C

Series Awards

Champion and Reserve Champion A, B, and C and Adult Riders will be recognized at the NSHJA Banquet.

Top Junior Equitation Rider will be honoured for the 2026 Series. Top Junior Equitation rider is determined by your top 10 scores based on judges cards (not placings) in any equitation class in throughout the series.

A year end top coach award will be announced at the NSHJA banquet.



INSTRUCTIONS FOR COMPLETING ENTRY FORMS

Entries must be in hand by the Monday prior to the first day of competition.

Entries will not be processed without full payment.

Ring numbers will not be issued if the entry is not paid in full.

All entry forms must be filled out completely, signed, and accompanied by full entry fees.

PLEASE NOTE THE FOLLOWING IMPORTANT RULE:

(A801.6 – General Regulations – Glossary: Person Responsible)

The Person Responsible (PR) for a horse must be an adult who has, or shares responsibility for the care, training, custody, and performance of the horse and who has official responsibility for that horse under EC Rules. The PR is liable under the penalty provisions of the applicable EC Rules for any rule violations.

Every entry form for an EC sanctioned competition must identify the PR and be signed by the PR.

The Person Responsible is ultimately responsible for the condition, fitness and management of the horse and is alone responsible for any act performed by himself/herself or by any other person with authorized access to the horse in the stables, elsewhere on the grounds, or while the horse is being ridden, driven or exercised.

A: For adult entries into EC sanctioned competitions the PR shall be either the trainer, the owner of the horse or the competitor who rides or drives the horse during the EC sanctioned competition.

B: For Junior entries into EC sanctioned competitions the Junior competitor cannot be the PR. For Junior entries the PR may be either the trainer, the owner of the horse, or a parent/guardian of the Junior competitor.
