



Restless Pines is pleased to welcome you back for another great season of competitions by offering several training dates for hunters and jumpers this summer, as well as two Gold Shows!









RULES & REGULATIONS

- 1. Dogs are welcome but MUST be on a leash at all times. Please clean up after your pet. Please be aware that Restless Pines dogs protect their farm!
- 2. There will be a food truck at the May training show.
- 3. No ring numbers given out without full payment of entries.
- 4. Parking We will be using the new outdoor competition ring and surrounding area (250' x 1000') as well as original parking area so we can have trailers and competitors adequately spaced.
- 5. Parking Spectators / families please park by your trailer and use the new outdoor arena area drive up to the outdoor ring turn left by the old canteen and over to the new area! Lots of space so we do not have to clutter the entrance to property and we can keep everyone well spaced!
- 6. Washrooms Portable Toilets will be available on the grounds.
- 7. Entries & waivers to be emailed with payment by etransfer by the Monday before each competition.

Divisions - \$50 per division - 2 o/f, 1 u/s per division

Jumper Classes - \$30 per class

All entry forms must be signed by horse owners, competitors and person responsible for horse. A parent / guardian signature required for all riders under the age of 19.

8. All walk trot and walk trot canter divisions will have two pleasure and one equitation class each.

The horse/pony hack division - 3 classes, 2 pleasure & 1 road hack.

Pole (Novice) Hunter 3 classes: one trot poles class, one canter poles class then under saddle

All hunter divisions have 2 over fences and one under saddle per division.

All rounds will be run back to back in threes.

All jumpers will have a welcome and a speed.

- 9. All divisions ribbons 1-6th with prizes donated by Greenhawk.
- 10. The Restless Pines Training Shows, its Management, Organizing Committee, Officials or Show Staff are in no way responsible for accident, injury or damage to any rider, exhibitor, spectator, groom, attendant, trainer or other employee; or animals, nor theft, loss or damage to animals, vehicles or equipment.
- 11. Competition numbers must be worn at all times.
- 12. Divisions will be combined if not enough entries at closing date. All heights will be offered if there are entries to promote riders moving up.
